HONESTY

In business life, Members adhere to the rules of honorable and honest conduct. In this context:

They do not knowingly harm others with their commercial activities and products. They do not use any information that must be kept confidential for their own benefit. They do not provide benefits to other persons and organizations in a way that would affect their decision-making ability, regarding the activities of their companies, subsidiaries, affiliates and companies or organizations with which they are affiliated or managed. They do not engage in or allow deceptive behavior by making misleading statements or promotions about their own and others' commercial and financial situations, or by knowingly turning a blind eye to such activities. They bear the responsibilities of their products and services and do not refrain from doing what is necessary. They do not violate consumer rights. They are inseparable from the basic principle of honesty and openness in bidding and contract negotiations. They do not engage in activities that would cause unfair competition by perverting the laws and internationally accepted principles of honesty. They do not demand that unfair profit be established for them, they do not intercede or ask anyone or any organization to act as an intermediary in this regard, and they reject any offers to this effect. They avoid attitudes and behaviors that would create a conflict of interest. They avoid transactions aimed at unfair competition and gaining profit through speculative or insider information, and do not engage in monopolization tendencies. They take special care in fulfilling their promises.

WORK ETHIC

In their relations with their employees, they comply with the basic principles of honesty, fair management, equality, providing a safe and healthy working environment, respecting their personalities, not forcing them to act against the law, contributing to their personal development.
